### Entry

3. Purchase period starts 12.01 am 12/10/2020 and ends 11:59 pm 31/01/2021 (AEDT), or until promotion stock runs out.
4. To participate in FIMER's 'Spring Into Summer' promotion, the solar installer/retailer must purchase an eligible product from selected distributors that have a FIMER "Peel & Reveal" sticker attached to the box.

6. Eligible product is the 5.0 kW UNO-DM-PLUS-Q inverter.
